Italy prohibits surrogacy




Ukraine, on the other hand, has one of the most liberal surrogacy frameworks in the world,



Surrogacy in Italy

Prohibition and Ethical Framework

- Complete ban under Law 40/2004.
- Legal void for contracts; no parental rights for intended parents.
- Ethical concerns rooted in Catholic values and societal views.
- Case example: The Brescia Court decision on surrogacy.



Surrogacy in Ukraine

A Liberalized Framework



Legalized under specific laws

Surrogacy is legal and regulated under laws such as the Family Code of Ukraine and related health and civil statutes.



Commercial surrogacy allowed

Ukraine permits
commercial surrogacy,
making it a popular
destination for couples
from around the world



Requirements

Only married heterosexual couples eligible.
Strict requirements for surrogate mothers, including health checks and contractual obligations



Hub for international surrogacy

The cost of surrogacy in Ukraine ranges from €40,000 to €65,000, significantly lower than in countries like the United States, where costs can exceed \$100,000.

Legal status

Italy's outright prohibition versus Ukraine's regulated industry



Ethical debates

Italy's focus is on preventing commodification and exploitation, whereas Ukraine faces criticism for insufficient safeguards to protect surrogate mothers.



Parental rights

In Italy, the surrogate is considered the legal mother, while in Ukraine, intended parents' rights are established at birth.






